Helena Kennedy is one of Britain's most distinguished lawyers and active public figures. She has spent her professional life giving voice to those who have least power within the system, championing civil liberties and promoting human rights.



A leading barrister and expert in human rights law, civil liberties and constitutional issues, she is a member of the House of Lords and chair of Justice – the British arm of the International Commission of Jurists. A bencher of Gray's Inn, she has been the chair of Charter 88, the Human Genetics Commission and the British Council. She also chaired the Power Inquiry, which reported on the state of British democracy.

Helena has acted in many of the most prominent cases of the last 40 years including the Brighton Bombing, the Michael Bettany espionage trial, the Guildford Four appeal and the bombing of the Israeli embassy. She was the British member of the recent International Bar Association Task Force on Terrorism issues.

A prominent author and broadcaster, Helena was a seminal force in promoting equal opportunities for women at the Bar. Ahead of her time, she was a singular voice in the seventies and eighties, writing and broadcasting on the discrimination experienced by women in the law, as lawyers but also as users of the law - victims and defendants. She became a member of the Bar Council to champion women in the profession and called for research into the experience of women lawyers and particularly their absence on the Bench.
