## V Strathclyde Postgraduate Colloquium on Environmental Law and Governance

Thursday 4 May 2017



The 2017 Colloquium will build on the success of the first four events when researchers from a wide range of countries presented their research on topical areas of environmental law and governance. Leading environmental law academics were invited to discuss the presentations, hence providing the researchers presenting with insightful comments and feedback. This format will be repeated in the 2017 edition.

The Colloquium offers two types of presentations:

**1. Oral Presentations.** Accepted presentations will be divided into thematic sessions that will be chaired by a member of the Strathclyde Centre for Environmental Law and Governance and will feature invited experts who will comment on the papers. Each presentation will last 15 minutes followed by ample time for debate introduced by comments from an expert on the field.



**2. Poster Presentation.** Accepted posters will be displayed at the Colloquium's venue and time will be given for the authors to introduce and discuss their work with participants. Posters should be A1 size.



Those interested in presenting should submit a 300-word abstract that provides a clear and concise overview of the intended presentation to [SCELG@strath.ac.uk](mailto:SCELG@strath.ac.uk). You may indicate your preferred form of presentation (oral presentation or poster) in your abstract. However, upon the acceptance of your abstract, you may be asked by the Colloquium organisers to present your work in an alternative format in consideration of the slots available for each category of presentation.

**The deadline for abstract submission is 01 February 2017.** Successful applicants will be informed by 15 February 2017.
