#### Postgraduate Diploma in Professional Mediation

*These regulations are to be read in conjunction with [General Academic Regulations - Postgraduate Taught Degree Programme Level](#).*

#### Admission

1. Applicants will:
  - i. Provide a personal statement of between 500 and 1,000 words in support of their application; and
  - ii. Possess an LLB or equivalent from a university authorised to grant such degrees by the Government of Saudi Arabia;
  - iii. or a qualification deemed by the Programme Director to be equivalent to (ii) above.

#### Duration of Study

The minimum duration of study will be 8 months

#### Place of Study

3. As permitted by [General Academic Regulations - Postgraduate Taught Degree Programme Level](#) the Postgraduate Diploma in Professional Mediation is delivered at the Saudi Judicial Training Centre (JTC) in Riyadh.

#### Mode of Study

4. The programme is available by full-time study only.

#### Curriculum
