These regulations are to be read in conjunction with the <u>General Academic Regulations -</u> <u>Postgraduate Taught Degree Programme Level</u>

Admission

- 1. Notwithstanding the <u>General Academic Regulations Postgraduate Taught Degree</u> <u>Programme Level</u>, candidates shall normally possess:
 - (i) a degree from a United Kingdom University; or
 - (ii) other qualifications deemed, by the Programme Director of the relevant study route, acting on behalf of Senate, to be equivalent to (i), above; or
 - (iii) be deemed, by the Programme Director of the relevant study route, acting on behalf of Senate, to have achieved an academic standard equivalent to (i) above, and
 - (iv) in addition, all successful applicants will be required to have had a period of relevant managerial experience. For applicants holding a degree of a University in the United Kingdom, or an equivalent academic or professional qualification, the period is normally three years. Other applicants, who lack formal qualifications require to have a minimum of five years of relevant managerial experience.

Mode of Study

2. The programmes are available by part-time study only.

Duration of Study

- 3. The duration of study for each level is:
 - i. Masters 24 months
 - ii. Postgraduate Diploma 21 months
 - iii. Postgraduate Certificate 8 months

Examination, Progress and Final Assessment

- 5. The <u>General Academic Regulations Postgraduate Taught Degree Programme Level</u> shall apply.
- 6. The final assessment will be based on performance in all elements of the programme.
- 7. Degree of **MSc Digital Transformation:** In order to qualify for the award of the degree of MSc in Digital Transformation, a candidate must have performed to the satisfaction of the Board of Examiners and must have accumulated no fewer than 180 credits.
- 8. **Postgraduate Diploma**: In order to qualify for the award of the Postgraduate Diploma in Digital Transformation, a candidate must have accumulated no fewer than 120 credits from the taught modules of the programme.
- 9. **Postgraduate Certificate**: In order to qualify for the award of the postgraduate Certificate in Digital Transformation, a candidate must have accumulated no fewer than 60 credits from the taught modules of the programme.
