These regulations are to be read in conjunction with <u>General Academic Regulations - Postgraduate Taught Degree Programme Level</u>.

#### Admission

- 1. Notwithstanding the <u>General Academic Regulations Postgraduate Taught</u>
  <u>Degree Programme Level</u>, applicants shall possess:
  - i. an upper second-class (2.1) undergraduate Honours degree or above.
  - ii. a lower second class (2.2) degree with demonstrable work experience, considered on an individual basis; or
  - iii. a qualification deemed by the Head of Department acting on behalf of the Senate to be equivalent to (i) or (ii) above.
- 2. Applicants for the MSc Occupational Psychology (BPS-accredited Professional Route, Stage 1) will also have Graduate Basis for Chartered (GBC) membership of the BPS and have obtained a Bachelor's degree or postgraduate degree from a BPS accredited programme.
- 3. In all cases, applicants whose first language is not English, shall be required to demonstrate an appropriate level of English.

### **Duration of Study**

4. The General Academic Regulations - Postgraduate Taught Degree Programme Level shall apply.

#### **Mode of Study**

5. The programme is available by full-time study.

### **Place of Study**

6. In accordance with the <u>General Academic Regulations - Postgraduate Taught Degree Programme Level</u>, some off-campus work may be required.

#### Curriculum

- 7. All students shall undertake an approved curriculum as follows:
  - i. for the Postgraduate Certificate no fewer than 60 credits,
  - ii. for the Postgraduate Diploma no fewer than 120 credits,
  - iii. for the degree of MSc no fewer than 180 credits including a dissertation.

- 9. In order to progress to the degree of MSc Work and Organisational Psychology and MSc in Occupational Psychology (both routes), a student must have successfully accumulated at least 120 credits from the taught modules of the programme curriculum.

#### **Award**

- 10. **Degree of MSc in Work and Organisational Psychology:** In order to qualify for the award of MSc in Work and Organisational Psychology a candidate must have performed to the satisfaction of the Board of Examiners and must have accumulated no fewer than 180 credits of which 60 must have been awarded in respect of the dissertation.
- 11. **Degree of MSc in Occupational Psychology:** In order to qualify for the award of the degree of MSc in Occupational Psychology (BPS Professional Route, Stage 1) and 40 credits awarded in respect to C8939 Quantitative Research Methods and C8985 Qualitative Research Methods.
- 12. **Postgraduate Diploma:** In order to qualify for the award of Postgraduate Diploma in Work and Organisational Psychology a candidate must have accumulated no fewer than 120 credits from the taught modules of the programme.
- 13. **Postgraduate Diploma:** In order to qualify for the award of Postgraduate Diploma in Occupational Psychology a candidate must have accumulated no fewer than 120 credits from the taught modules of the programme, including 40 credits awarded in respect to C8939 Quantitative Research Methods and C8985 Qualitative Research Methods.
- 14. **Postgraduate Certificate:** In order to qualify for the award of Postgraduate Certificate in Work and Organisational Psychology a candidate must have accumulated no fewer than 60 credits from the taught modules of the programme.
- 15. **Postgraduate Certificate:** In order to qualify for the award of Postgraduate Certificate in Occupational Psychology a candidate must have accumulated no fewer than 60 credits from the taught modules of the programme, including 40 credits awarded in respect to C8939 Quantitative Research Methods and C8985 Qualitative Research Methods.
