OPEN BUSINESS

12841. Welcome

The Principal welcomed all members to the third meeting of Senate in AY 2023-24 which was held fully online.

12842. Minutes of the meeting of 7th February 2024 (Paper S23-24-43)

The minutes of the meeting of 7th February 2024 were approved as an accurate record.

12843. Matters Arising

There were no matters arising.

12844. Senate Business Committee Report (Paper S23-24-44)

The Vice Principal invited Senate to note the report from Senate Business Committee which met on 18th January 2024. The Committee had scrutinised the following:

- The note of the Collaborative Provision Agreement (CPA) Subgroup noting that since the last meeting of Senate on 15th November 2023 the CPA Subgroup had processed six agreements, two of which were reviewed out of cycle and reported 'for information' in the relevant Faculty reports to Senate. All six agreements were renewals or additions to existing partnerships, with five being articulation agreements and one a validation.
- 2. The New Awards Recommendation Group (NARG) reviewed a proposal from the Faculty of Humanities and Social Sciences by circulation on 11th January 2024 and detailed in the HaSS Report to Senate (Paper S23-24-57). The Award of the Certificate of Continuing Education operates at SCQF level 7, 8 & 9/ Strathclyde levels 1, 2 & 3 and is therefore presented to Senate for endorsement and onward approval at Court and listing in the University's Ordinances. A search of past Senate records dating back to 1992 did not find a record of approval of this Award and it does not currently appear in the Ordinances. Senate Business Committee recommended the new Award to Senate for endorsement and recommendation to Court for approval.

Senate ENDORSED the Award of Certificate of Continuing Education and recommended this to Court for approval and inclusion in the University's Ordinances.

- 3. The Committee agreed the business agenda for Senate's meeting on 7th February 2024. The Strath Union President was asked to provide a verbal update on recent Strath Union business. It was agreed that Helyn Gould, Deputy Associate Principal Education Systems and Enhancement, would present to Senate on preparations in place for NSS 2024 with a short verbal update on specific Faculty preparations being provided by the Executive Deans. Brian Green, Deputy Associate Principal Academic Quality and Student Experience would provide Senate with an overview of the PGR Monitoring Framework noting that the Framework was also provided as a paper on the Senate Agenda, Paper S23-24-61. Dr Lizann Bonnar, Convener of Expert Working Group on Generative AI Teaching Learning and Assessment, Karen Barton, Deputy Director Education Enhancement and Dr William Hasty, Learning Enhancement Advisor would be invited to present on Generative AI, specifically in relation to ongoing activities in this area within the University, the opportunities it presents and approaches to assessment. Finally, Senate would receive a recruitment update from Wesley Rennison, Director of Strategic Planning and a financial update from Lucy Noble, Chief Financial Officer.

12845. Principal's Report

The Principal provided a comprehensive report on news and items of interest since the last meeting, covering the following topics:

Key Updates

The Principal informed Senators of the passing of Professor Arthur Midwinter, former Dean of Arts and Social Sciences. Reflections on the remembrance event celebrating the life of Professor Sir John Arbuthnott were shared, and Senate noted the invaluable contributions of both of these individuals to the University.

There are a number of challenges facing the sector at present, in particular the policy around immigration and the resultant visa restrictions which are impacting international recruitment across all HEIs. Senators were encouraged to read PWC's <u>UK Higher Education Financial Sustainability Report</u>.

Strathclyde 2030

The new <u>University Strategy 2030</u> was launched, the launch event was very well attended. The shaping of the Strategy has have benefitted from an unprecedented level of connectivity across the Strathclyde community. The Principal extended thanks on behalf of Senate to all involved in its development and launch.

Strathclyde People

Three Strathclyde colleagues were recognised in the New Year's Honours List for their contribution to their professional fields, including an OBE for Professor Gavin Halbert, Director of the Cancer Research UK Formulation Unit in the Strathclyde Institute of Pharmacy and Biomedical Sciences, and MBEs for Professor Roma Maguire, Director of Health and Care Futures at Strathclyde, and Professor Yvonne Perrie, Head of the Strathclyde Institute of Pharmacy and Biomedical Sciences.

Professor Tim Bedford has been elected as Vice President of CESAER, the European universities group that provides a strong and united voice for the universities of science and technology in Europe.

Professor Roma Maguire has been appointed to the role of Deputy Associate Principal, Health and Care Futures, where she will take strategic leadership in health and care futures, an important area of development for the University.

Queen's Award 2023

The University was awarded Queen's Anniversary Prize for Higher and Further Education for recognition of the work in the field of Photonics. This is the third successive Queen's Anniversary Prize the University has won in recent years – making us one of only a handful of institutions to have achieved such a feat – and it is our fourth award in total.

Living Wage

The University has reaffirmed its ongoing commitment to the Voluntary Living Wage. The increased Living Wage took effect from 1 December 2023. This has resulted in an increase in the hourly rate of our Grade 1 staff from £11.18 per hour to £12 per hour. Those colleagues on Grade 2 and those on the points in the normal range of Grade 3 now also receive a Living Wage Allowance to ensure that pay rates reflect the differing levels of responsibility between these grades. The revised pay scales outlining the new hourly rates can be found on our <u>website</u>.

Successful Recognition

The University received positive recognition in a number of rankings, including: Strathclyde Business School being the highest-placed business school in Scotland in the Financial Times; the Leiden Open Rankings ranked Strathclyde 3rd out of 1,200 institutions, with 91.7% of research output being published through Open Access; and the University was placed in the top decile, at 107th out of 1,397 institutions across 95 countries, in the Quacquarelli Symonds (QS) Sustainability Rankings 2024.

LGBT+ History Month and Race Equality Week

A full programme of events has been organised and hosted by the University and Strath Union for February's LGBT+ History Month and Race Equality Week.

12846. Student Voice

Eva Curran, Strath Union's President, presented the Strath Union update which reflected on the success of Refreshers, the new spring graduation ceremonies, and the build up to the upcoming student elections. The University and Union Executive Teams had met and discussed a number of themes related to the Strategic Alliance, including student spaces on campus and equity of access, and how to better engage students in building community post-COVID-19. It was noted that the upcoming student engagement events on the report into the University's historic links to the transatlantic slave trade would be a good opportunity to continue this work of community building. Strath Union are working with NUS Scotland to challenge the cuts made by the Scottish Government to the HE and FE Budget, and they are working with Glasgow Student Forum to campaign for a Council Tax grace period for recent graduates.

12847. NSS 2024

In Helyn Gould's absence Brian Green presented on University preparations for NSS 2024. This included reflections on the positive and stable results from 2023, and a timeline of key dates for 2024. This was followed by a brief verbal update from the Executive Deans on preparations specific to each Faculty. New initiatives to encourage completion of the NSS included newsletters, coffee and chat sessions, and 'you said we did' communications. The focus of each Faculty was improvement in the Student Voice and Assessment & Feedback areas of the NSS.

12848. PGR Monitoring Framework Update

Brian Green updated Senators on the Postgraduate Research (PGR) Monitoring Framework. The Framework is designed to outline minimum expectations for PGR study, and support colleagues to share examples of best practice taking place across the institution. It is hoped that embedding a highquality PGR student experience in combination with academic excellence will support the objective to expand the PGR community.

12849. Generative AI – opportunities, resources and assessment

Dr Lizann Bonnar, Karen Barton and Dr William Hasty provided Senate with a presentation around the opportunities associated with Generative AI in learning, teaching and assessment, while recognising its challenges. The Expert Working Group on Generative AI has so far produced <u>guidance for colleagues</u>, delivered a number of well attended staff sessions, released several micro-CPD modules, and is engaging in a JISC sponsored pilot of a teaching support AI tool. Colleagues reflected that whilst there is concern in this area around academic integrity and the range of work that need to be undertaken to support assessment, that there are many opportunities to use Generative AI to innovate across the institution.

The Principal thanked all three speakers for such an informative and engaging session on Generative AI and asked that this topic be presented to Senators again in the near future.

12850. Recruitment and Financial Update

In Wesley Rennison's absence the University Secretary, Dr Stuart Fancey provided Senate with a recruitment update, noting that whilst PGT overseas applications numbers were steady this had not translated into registrations. The sector wide factors that have impacted the student recruitment market, including changes to UKVI rules were discussed in relation to 2023/24 recruitment numbers. The Chief Financial Officer, Lucy Noble presented Senate with an overview of income and expenditure movements noting that whilst the recruitment and market challenges were having an impact that this had been mitigated by strategic savings in other areas and the University remains is a strong financial position. The budget for 2024/25 is currently being reviewed and will be presented to Court at its June meeting.

It is proposed that Senators whose first term on Senate is coming to an end may be nominated for a second three year term by their Faculty representative on the Senate Business Committee, in consultation with the Senator, and their Executive Dean, and proposed to the Senate Business Committee. This will negate the need to submit a newly completed and signed nomination form.

Senate APPROVED the pilot proposal noting that Senate will be provided with a report on how successful the pilot has been at the September Senate.

New of Revised Policy

12865. University Timetabling Policy (Paper S23-24-60)
