


OUP Open Access Account User Guide

Authors from participating UK institutions can use funds to pay open access charges when publishing in 400+ OUP journals

To be eligible to publish open access and use funding from the UK institutions (Jisc affiliated) account you must be:

1. the corresponding author of the article
2. affiliated to one of the participating UK institutions
3. publishing in an eligible journal
4. publishing a research or review article

Follow these **FIVE** simple steps:



Step 1 – Sign in

Once your article has been accepted for publication, you'll receive an email from the OUP production team with a link to OUP's online licensing and payment system.

Click on the link and sign in using your Oxford Academic account.

- 2 Fill in your Username and Password
- 3 Click 'Sign In'

Step 2 – Choose OA licence

Once logged in, choose the appropriate licence under which your article will be published in the journal. **To publish open access and request use of UK institutions (Jisc affiliated) funds you should choose one of the open access licences available** (the range of open access licences available varies by journal), and then click the green 'Select' button at the bottom of the page. If you're unsure of your eligibility, check with your institution before agreeing the licence.

If you are eligible for use of UK institutions (Jisc affiliated) funding, you will not need to pay the OA charge. If page or colour charges apply for your article, you will need to arrange payment for those – check the journal Instructions to Authors page for details of charges.
